I am delighted to report that this year we sponsored 382 girls in 30 Commonwealth Countries. 101 girls completed their final year in secondary school during the year covered by this report. To follow their progress, we hope to garner more news of the CGEF Alumnae in the coming months and years, having recently formed a vibrant and active Alumnae subcommittee.

I would like to thank my incredibly loyal and hardworking board of Trustees, who, supported by Danielle, our hugely capable administrative secretary, continue as always to work tirelessly without either recompense or expenses. Introduction

The CGEF delights in receiving handwritten letters from every girl we sponsor every year — a collection of very special reflections by girls across the Commonwealth that share the joys and challenges of valuable education. It is interesting to read how much these girls have in common with each other in terms of both personal and schooling experience, despite living in 30 very different countries across the globe.

The effects of climate change are becoming increasingly apparent, with natural disaster featuring in many of the letters we receive. In early 2015, cyclone Pam brought chaos to Vanuatu where 3 of our girls could not be contacted for many months.

Later that year, Tropical Storm Erika hit Dominica affecting the start of a new school year for 5 of our girls and leaving many without water, electricity, jobs and in some cases, loss of life.

In other cases, disease such as HIV/AIDS have taken away the innocence of childhood as many

The following report details the successes and difficulties faced by 'our girls', including genuine handwritten letters, school reports and photos. We have changed the names to protect their identity.

Handwritten letter from a CGEF girl in Africa

Our girls in the Caribbean, Central and South America have been progressing very well; however, occasionally personal or health related issues can affect their schooling.

For instance, Jane in Belize did not return to school at the beginning of the academic year, and after the CGEF pressed for information on her whereabouts, it was discovered that she had been treated for a 33lb tumour that was growing in her stomach. Many in her community had thought she was pregnant.

Thankfully Jane got the medical care she needed, the tumour was removed and she is now recovering well.

The CGEF was delighted to inform Jane that she will not lose her sponsorship and she is expected to resume her secondary schooling in September 2016. The CGEF will always

support and encourage girls who have faced difficulties throughout the year, offering letters of encouragement or praise in recognition of their efforts.

However, it is particularly special when we receive a letter from a girl who has not only shown self-improvement, but actively seeks to help and support others. In St Kitts, Shelly writes:

'I continue to be a very community oriented individual who helps where

help is needed. These extra-curricular activities have assisted in my overall development as an individual. I am very fond and passionate in helping and giving back to my community'

This year the Commonwealth Girls Education Fund has been working very closely with Pacific High Commissions to establish new contacts in this vast area of the Commonwealth.

For the first time in 2016, the CGEF will sponsor girls in Fiji and with this gift of education, Winnie writes:

"My ambition in life is to become a lawyer, a barrister in particular that looks after the interests of children. Additionally, I aim to be independent and make my parents proud"



Like so many of our successful CGEF sponsored girls, Winnie's goals will not only benefit her own future, but that of her family and wider community too.

Headteacher's recommendation for renewal of sponsorship for girls

Thank you for the assistance provided to four of our girls over the last academic year, 2014-2015. Two of the four girls, that is Yvonne and Daisy have graduated and moved on to higher education at other institutions. Currently we have enrolled with us Francis and Serieux.

I, therefore take the opportunity to submit and request a renewal of scholarship for these two girls for the period 2015-2016. Both of these girls continue to lead by example in their deportment, level of motivation and work ethic. Their Home-room sponsors and subject teachers continue to be impressed with the quality of work they produce and the timely manner in which they hand in assignments. They also present as having well developed interpersonal skills which are effectively used with both their peers and staff.

Owing to the above observable behaviours the administration and staff strongly endorse these students as suitable recipients for the Commonwealth Countries League Education Fund.

Asia

India: The end of the 2015/2016 financial year saw 38/71 of our girls in India get ready for their end of school exams; and it is with great pleasure that the Commonwealth Girls Education Fund have been able to witness these girls turning into high achieving young women.

However, despite their year on year academic improvement, poverty still threatens the chances of girls receiving a secondary education as Rubina mentions in her letter:

"I have no father [and] my mother's monthly earnings are not at all enough to meet the educational expenses of my brothers and myself. We are living in very poor economic conditions".

Ten blind girls in Tamil Nadu will complete five years of secondary sponsorship by the CGEF in 2016. Being blind as well as being female is a huge disadvantage.



With financial support they have not only been able to benefit from a specialist education for blind students, but have turned out to be some of the highest achieving students under CGEF sponsorship in India. Lakshmi writes in braille, which has been translated:



"With your great support and motivation I have completed my education successfully. It also powers me to shine in this society"

The fact that every one of these girls is in school is a miracle and we look forward to assisting more girls from the Indian Association for the Blind in 2016.

Across Asia, the career aspirations of our girls go far beyond their present economic constraints and it is encouraging to see how much they value education and its power to elevate them from abject poverty. Our girls recognise the difficulties faced by their parents in achieving a decent living to support their families, as Sultana explains:

'As my father passed away it is difficult for my family to bear my education expenses. I want to be more successful in future and become a Doctor. With the help of your sponsorship I can fulfil my dream'.



Pakistan: Our girls in Pakistan continue to perform well and reliably engage in the CGEF's call for action when we need a piece of artwork to showcase at our fundraising events. In December 2015, five of our girls in Lahore sent the Trustees Christmas cards as a thank you for the support they receive from the fund.

In her card, Ayesha wrote:

"You have given me encouragement and hope in a difficult time. Thank you very much"

The CGEF will sponsor girls regardless of their religious or cultural background, so it was lovely to receive such a heartfelt gift in return.

59% of the 382 girls sponsored by the CGEF in 2015/2016 are living in African countries; and with this comes an awareness of a host of economic, cultural, political & social issues which often heavily affect the lives of our girls on a daily basis.

However, it is these issues which drive our girls to setting their sights and personal ambitions high and achieving their goals.

In Nigeria, Gladys was absent from school for two weeks when she was diagnosed with typhoid and malaria; but with the ongoing support of the charity and help in how to catch up with her studies, she was able to quickly pick up her secondary schooling.

She writes:

"I would like to appreciate your wonderful effort towards girls education... This scholarship you have given to me will help my goal of becoming a lawyer so as to protect and defend my nation"

In Tanzania, six of the thirteen girls we sponsor there completed their secondary schooling and sent beautiful photographs of their graduation ceremony in traditional dress. The gift of education is far reaching, with many of the girls utilising their knowledge to aid others in need. In her letter, Nani told us:

"I [will] use the things that I have learnt in school by teaching the village children how to read, write and count. I really learned a lot in school"

A handwritten letter from one of our girls in 2015 (SOS is the name of the orphanage where our girls live) Thanks to the help of the Botswana High Commission, CGEF was able to sponsor 3 girls in 2015/16. Angela's letter beautifully illustrates how our girls view education and why they do not take it for granted.

Uganda received the highest number of CGEF sponsorship grants in the African continent in 2015/16. Many more applications are received from all over the Commonwealth each year than the charity is able to afford. It is often the case that head teachers have to send girls home for late or non-payment of fees, leading to academic disruption and more importantly, the view from parents that it's not worth educating their children when money is so hard to come by. Many families need their children to work in order to help support the family otherwise they can be married off, or sold for cattle, in order to lessen the burden on the family purse.

By sponsoring a girl for a year, the worry of being sent home or worse is lifted from the girl's shoulders. In her letter Justine told us:

"Before I got the sponsorship I was always moving up and down and I could miss classes which affected my performance even though I tried. Whenever they issued out meal cards to those who have completed school fees, I would not be given one, so I missed my meals sometimes as well"





CGEF Alumnae Association

The CGEF Alumnae Association aims to build a network of friendship among women who were formerly sponsored by the Commonwealth Girls Education Fund. Many of our girls went on to become successful women, often going back home to help the communities they grew up in.

Below are the stories of some of 'our girls' who turned into empowered women.

Following four years studying at the University of Guyana, Kimberly now works for the Department of Education as a Schools Welfare Officer. The region she covers in the mountainous west of the country is one of the largest so it is a demanding job.

Following the completion of her degree in nursing in Uganda, Josephine became the African students' representative of TUFH's Student Network Organisation. TUFH (Towards Unity for Health) is a global network committed to improving the health of people and their communities and this is very much where Josephine's interest lies. Having previously attended the TUFH Conference in

Brazil, she became involved with arrangements for the 2015 conference which was hosted by the University of Pretoria in South Africa.

She wrote "coupled with the transportation difficulties, being responsible for the welfare of almost 9,000 students in 83 schools scattered across the

region is sometimes overwhelming. However, I am concerned about the status of education for the future of our children, hence my desire to make a difference in their lives always hoping for a better tomorrow".

Kimberly was very involved with the National Science Fair and sent photos of the participants in the Regional Science Fair in her area.

Unfortunately previously sponsored students in some countries have had to face disappointment as they have been unable to access funding to continue their studies at university or other

training institutions. One of these is Opuruta in Papua New Guinea. She had hoped to complete her medical studies but had to withdraw from university due to lack of funds. However, some of the girls from the Highland Provinces in PNG have gone on to successful careers. Matilda is a secondary school teacher, Mary an environmental scientist while Rosylen is working in the legal field.

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF COMMONWEALTH GIRLS EDUCATION FUND (CGEF) FOR THE YEAR ENDED 31 MARCH 2016

I report on the accounts of the Charity for the year ended 31 March 2016

Respective responsibilities of trustees and examiner

The Charity's Trustees are responsible for the preparation of the accounts. The Charity's Trustees consider that an audit is not required for this year under section 144 of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.

It is my responsibility to:

- examine the accounts under section 145 of the 2011 Act; "follow the procedures laid down in the general Directions given by the Charity Commission under section 145(5)
 (b) of the 2011 Act; and
- state whether particular matters have come to my attention".

Basis of independent examiner's statement

My examination was carried out in accordance with general Directions given by the Charity Commission. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the accounts present a "true and fair view" and the report is limited to those matters set out in the statement below.
